

SDABL --- PARTICIPANT CONTRACT

I participate as a (Circle One) **PLAYER COACH MANAGER** and hereby consent and agree to the following parameters and conditions of participation in the San Diego Adult Baseball League (SDABL) and its national affiliate, the National Adult Baseball Association (NABA).

1. I will abide by the rules of the SDABL as published by the SDABL and further understand the SDABL reserves the right to make changes in the rules without prior notification. I understand the SDABL, in its sole discretion, reserves the right to refuse any player or team permission to play in any SDABL league at any time and without prior notice. I understand that fighting, physical abuse of players, umpires, or spectators, or abusive language directed at players, umpires, or spectators is not tolerated by the SDABL.
2. I will not possess or consume alcoholic beverages or drugs at any time on the playing field, in the dugouts, bleachers, or other areas near or around the playing field, or within one hundred yards (100) of the playing field facility, including, but not limited to, the parking lots of any high school, college or city/county recreation facility.
3. I certify that I am at least 18 years old to participate in the 18&over league (or will turn 28 yrs old to participate in the 28&over, 38 yrs old to participate in the 38&over, 48 yrs old to participate in the 48&over-during the current calendar year) at the time of my execution of this contract and understand that I must be able to identify myself with a drivers license or other photo ID at any officially scheduled SDABL game upon request, or I will be ineligible to participate in an SDABL game. I understand that violation of any part of this Contract may result in disciplinary action against me and/or my team, including, but not limited to, forfeiture of games, suspension from play, fines, or permanent expulsion from the SDABL.
4. I understand that no refund of my share of the team fee or the add-on fee will be due me for any games for any reason. The terms/provisions of this Contract shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, successors and assigns.
5. I realize that the total responsibility of any personal injury, accident, illness, disability or death to me or my person while I am participating in any SDABL/NABA function, including but not limited to, any SDABL mandated or scheduled function, is solely mine. I understand that the SDABL/NABA **does not provide medical insurance**; only property damage and liability insurance. I realize that I am responsible for the first \$250.00 on any property damage or liability claim that may arise due to my actions.
6. As a manager of the team set forth below, I hereby acknowledge that I have read the Manager's Rulebook & Guidelines (SDABL Rulebook) provided to me by the SDABL, that I have advised my team of the rules therein and my team understands that they will be held responsible for any violations of these rules. I further agree that it is my responsibility to collect the team fee and turn it over to the league before the start of the season. I am eligible to play as a player in any regularly schedule game. I further understand that I must maintain a minimum of 10 players under contract at all times plus a coach. I agree that I will submit this Contract to the league prior to any draft and state that I am drafting players for the sole purpose of playing in an SDABL/NABA league and not for the purpose of entering my team/players in a non-SDABL sanctioned league within this calendar year. I hereby agree to be personally liable to the SDABL in the amount of \$150.00 per player for each and every player which I direct to a non SDABL sanctioned league by my actions or by the actions of those under my control or whom are acting on my behalf. I also hereby agree to submit all signed player contracts to the SDABL prior to the start of the season.
7. This Agreement and all of its terms and conditions shall be interpreted by and under the laws of the State of California without regard to the principals of conflict of law. Any adjudication of this agreement shall be under the laws of the Sate of California and all parties agree to submit to exclusive jurisdiction of the Courts of the City and County of San Diego, California.

WAIVER

In consideration of the foregoing and being allowed to participate in SDABL/NABA activities of functions, and intending to be legally bound for myself, my heirs executors and administrators, I do hereby release and discharge the SDABL/NABA, including, but no limited to, the SDABL/NABA, Inc., the National Organization, its officers, directors, agents, contractors and employees, the local league presidents, league commissioners and managers, and city, county and/or state organization school district or board or any other governing body that may have jurisdiction over any public baseball field or other facility that I might play on, any other owners, lessors or providers of fields or facilities (whether privately held or otherwise), umpires organizations, and their respective officers, directors agents, contractors, employees and other players in their respective Associations, jointly and severally, from any and all liability from personal injury, accident, illness, disability, death, property damage (except as provided in item 4 above) or other occurrence which I may suffer in any manner whatsoever arising out of or resulting from my participation in any SDABL/NABA activity or function.
